Product Description:

SUPERIOR is a bulk non dusty synthetic laundry powder, containing highly active yet low foaming detergents, optical brighteners and soil suspending agents, oxygen releasing bleach, eucalyptus oil *and added enzyme action*.

SUPERIOR is suitable for low or high temperature laundering. The natural eucalyptus oil imparts a clean fresh smell to the finished load & builds solvency to improve cleaning

Application:

Recommended for all large commercial laundering as well as smaller operations such as nursing homes, colleges, motels and hotels. SUPPERIOR is suitable for TOP & FRONT loader machines.

Most laundries follow set procedure to suit their particular need in break wash and bleach cycles. It is generally recommended that SUPERIOR be used in quantities varying from 75 - 200 g per 12 - 25 kg load. The quantities may need to be increased in areas where the water is exceptionally hard. Domestic front- loading machines require between 50 and 100g per 12kg for light to medium soils.

1.Concentrated

The highly economical aspect of using SUPERIOR is obvious when only 1/4 the quantity is required to do the same work as that suggested for fluffed or spray dried.

3.Stops Greying
