Application:

Spray and Wipe

Dilute 40ml CITRUS WIPE into a 750ml spray bottle. Spray onto hard surfaces, allow to act, wipe to remove. No need to rinse!

To Clean Floors

To quickly clean and shine kitchen vinyl and tile floors, dilute 1 part CITRUS SWIPE to 40 parts water. Mop or scrub the surface, pick up with the mop or wipe the excess solution, no need to rinse, unless surface is a potential food contact area.

Heavy Duty Degreasing

Dilute 1 part CITRUS SWIPE to 4 parts water. Mop, wash or scrub surface, leave for 5 minutes and then pick up with mop or wipe excess solution, no need to rinse.

CITRUS SWIPE MULTI PURPOSE CLEANER DEGRESER is a universal cleaner designed for regular maintenance procedures. As the degree and type of contamination determines in most cases the concentration, recommendations can only be given.

- Light Duty Cleaning: 1 part CITRUS SWIPE to 40 60 parts water.
- Medium Duty Cleaning: 1 part CITRUS SWIPE to 10 20 parts water.
- Heavy Duty Cleaning: 1 part CITRUS SWIPE to 2 4 parts water.
