# Matador

## Alkaline Detergent Sanitiser

### Product Description:

MATADOR is a clear green liquid that is an effective blend of high powered soil removers and sanitisers. MATADOR is described as a "Quick Break Detergent" and has been tested to break within the 20 minute parameter. MATADOR works efficiently in hard or soft water and rinses freely to leave no residue. MATADOR is powerful enough to clean heavy soils and is mild enough to be used without harm to hands or other skin areas. MATADOR is concentrated - a little goes a long way. MATADOR contains - no caustic, no solvents and no soaps.

### Application:

MATADOR is a universal cleaner designed for regular maintenance procedures. As the degree and type of contamination determines in most cases the concentration, recommendations can only be given.

Light Duty Cleaning - 1 part MATADOR: 60 - 80 parts water.

Medium Duty Cleaning - 1 part MATADOR: 30 - 40 parts water.

Heavy Duty Cleaning - 1 part MATADOR: 10 - 20 parts water.

#### To Disinfect and Clean

Dilute 1 part MATADOR to 60 parts water. Mop or scrub the surface, pick up with the mop or wipe the excess solution, no need to rinse.

#### All Purpose Cleaner

Dilute 1 part MATADOR to 80 parts water. Mop or scrub the surface, pick up with the mop or wipe the excess solution, no need to rinse.

#### To Clean Kitchen Floors

To guard against Gastroenteritis and other diseases, dilute 1 part MATADOR to 60 parts water. Mop or scrub the surface, pick up with the mop or wipe the excess solution, no need to rinse.

#### Washing Polished Floors

Dilute 1 part MATADOR to 80 parts water, damp mop, no need to rinse. Buff to a high shine.

#### To Clean Workshop Floors

Dilute 1 part MATADOR to 10 parts water. Mop, wash or scrub surface, leave for 5 minutes and then pick up with mop or wipe excess solution, no need to rinse.
